NOTICE OF RACE

The 2011 Victorian Dinghy Championships & 2011 Victorian Laser Port Phillip Regatta will be held from December 10th – 11th 2011 inclusive. The organising authority for 2011 Victorian Dinghy Championships and the 2011 Victorian Laser Port Phillip Regatta is Mordialloc Sailing Club Inc on behalf of Yachting Victoria and the Victorian Laser Association Inc respectively. The events will be conducted concurrently by Mordialloc Sailing Club Inc.

1. Rules

- 1.1 The event will be governed by the rules as defined in the Racing Rules of Sailing (RRS)..
- 1.2 Yachting Australia Special Regulations, Part 2, Off the Beach Boats will apply.

2 Advertising

Boats may be required to display advertising chosen and supplied by the organizing authority. The organising authority reserves the right to refuse advertising by a boat or competitor when it is in conflict with an event sponsor or the laws of the Victorian or Australian Governments.

3. Eligibility and Entry

- 3.1 Entries for 2011 Victorian Dinghy Championships will be accepted for any class of mono hull off the beach dinghy & Flying 15. Racing will be based on Yachting Victoria yardstick grouped divisions.
- 3.2 Entries for the 2011 Vic Laser Association Port Phillip Regatta is open to financial members of a Laser District entering a Laser Standard, Laser Radial or Laser 4.7.
- 3.3 Eligible boats may enter by completing the attached Entry Form, which shall be lodged with the Race Secretary of Mordialloc Sailing Club Inc by 1030hrs Saturday 10th December 2011, or enter online at http://www.mordiallocsc.com.au/event-registration/?regevent_action=register&event_id=4&name_of_event=Zhik2011VictorianDinghyChampionships&2011_Victorian_Laser_Port_Phillip_Regatta. Online entries will close 2200hrs Friday 9th December 2011.

4. Fees

The Entry Fee for the 2011 Victorian Dinghy Championships is: **\$40.00**
The Entry Fee for the 2011 Victorian Laser Port Phillip Regatta (includes 2011 Victorian Dinghy Championships) is: **\$50.00**

There is a maximum of eight races scheduled, the start times for the second and succeeding races on each day will be as soon as practical after the conclusion of the preceding race, at the discretion of the Principal Race Officer.

6. Measurement



All competing yachts shall conform to the measurement requirements specified in the appropriate class rules. Measurement checks may be carried out at any time during the regatta.

7. Sailing Instructions

Sailing Instructions will be available from the Race Secretary of Mordialloc Sailing Club Inc. at registration.

9. Racing Area

The racing area will be on the waters of Port Phillip off Mordialloc Sailing Club.

10. Courses

The format and courses to be sailed will be detailed in the Sailing Instructions.

11. Penalty System

For the 29er, 49er, Musto Skiff & B14 classes, rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12. Scoring

12.1 A maximum of 8 races are scheduled, of which 3 races shall be completed to constitute a series.

12.2 When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

12.3 When from 5 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

13. Personal Flotation

All competitors shall wear personal flotation devices, which are in good condition and are in accordance with the specifications issued or approved by the national authority. Attention is drawn to Fundamental Rule 1.2.

14. Support Boats

14.1. Team managers, coaches and other support personnel shall register by completing a registration form available at registration.

14.2. Approved Support Boats shall keep at least 100m clear of the course area during racing, except when asked to assist by the race committee.

15. Rights to use Names and Likeness

In participating in an event, a competitor automatically grants to the organising authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.

16. Radio Communication

Except in an emergency, a boat will neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

17. Prizes

Prizes will be awarded at the discretion of Mordialloc Sailing Club Inc. and the Victorian Laser Association Inc.

18. Disclaimer of Liability



Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision To Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

19. Insurance

- 19.1 All boats shall have third party insurance cover of not less than \$AUD5,000,000 (recommend \$AUD10,000,000 or equivalent thereof in any other currency) for any accident.
- 19.2 All owners/competitors who sign the entry forms are deemed to have made a declaration that they hold such cover. Owner/competitors not holding this cover shall withdraw their entry.
